



Eligibility, Terms, and Conditions

Eligibility, Terms, and Conditions of the DermaMed Solutions Aesthetic Education Award

The [DermaMed Solutions Aesthetic Education Award](#) is presented to the chosen applicant interested in attending an accredited aesthetic program, who expresses their passion for the skincare industry and shares the core values of DermaMed Solutions. DermaMed Solutions will present \$500 to the recipient's chosen accredited aesthetic program for educational expenses. The award amount will be increased by an additional \$500 for a total of \$1,000 if the recipient is enrolling in one of our [Aesthetic Partner Schools](#).

- Legal residents of the United States only.
- Must be legally eligible to attend an accredited aesthetic program.
- An award committee will review the applications which meet eligibility requirements and select the applicant who best shares the core values of DermaMed Solutions to receive the award.
- Recipient must enroll in an accredited aesthetic program of her/his choice, within 1 year of notification of award.
- Payment of award will be paid directly to the accredited aesthetic program of recipient's choice for educational expenses.
- The award amount paid is \$500 per award, unless otherwise stated.
- The award amount will be increased to \$1000 total if the recipient is enrolling in one of our Aesthetic Partner Schools.
- One award will be given with a max of two awards given per year.
- Limit of one entry per person per application period, and one award per recipient.
- The deadlines for applications are January 31st and July 31st of each year.
- Award will be forfeited by recipient if the above requirements are not met.
